# RULES AND REGULATIONS

1. Each Junior Teen entrant must be at least 11 and no older than 13 on January 1, 2010. Teen Entrants must be at least 14 and no older than 18 as of January 1, 2010. Contestants in the Kentucky's Miss Princess Divisions will determine their age division according to their age on the day of the pageant; Tiny 3-4, Little 5-7, and Young 8-10. (Young Miss Contestants that turn 11 before Pageant weekend will be Jr. Teen).
2. Entrants must be born female, single, never married, nor given birth to a child, be of good health and moral character.
3. All decisions as to the eligibility shall be determined by The Miss Kentucky Teen America Organization.
4. All decisions of the judges are final and irrevocable.
5. Any contestant and/or family member or guest showing unsportsmanlike behavior will lead to the disqualification of the contestant. No refunds will be given.
6. If for any reason a winner is disqualified, or elects not to participate in the national competition, her title and all awards including crown and banner, trophy, cash and other prizes will be returned to the State Office and given to the next choice of the judges. I understand that the contestant whose title is relinquished or who is disqualified shall be responsible for any and all court costs, and attorney's fees incurred by The Continental Miss Teen America Scholarship Program in an effort to have the aforementioned property returned to the state or national pageant.
7. Entrants hereby agree to release unconditionally and forever, any claim against Miss Kentucky Teen America and The Continental Miss Teen America Scholarship Program, Inc., its officers, directors, employees, agents, subsidiaries, which they may have, by virtue of their participation in this pageant or any use of their name, likeness, voice and/or biography in connection with this pageant, including use in promotional and advertising material.
8. The Miss Kentucky Teen America Organization and the Continental Miss Teen America Scholarship Program, Inc. reserves the right to change the date and location of the State and/or the National pageant. This may or may not include reasons such as severe weather or other unpredictable events. If for any reason the date of the pageant is moved, entry fees will not be refunded should a contestant choose not to compete on the rescheduled date.
9. Jr. Teen and Teen entrants agree that if they enter a state preliminary and succeed to a state level title, or to the title of Miss Teen America/Miss Jr. Teen America they will not participate in any pageants during the time that they hold either of those titles, unless authorized in writing by The Continental Miss Teen America Scholarship Program, Inc. Kentucky's Princess Titles are non-contractual and winners may compete in other pageants throughout their reign.
10. Contestants and their parents/guardians agree to hold harmless all persons affiliated with the Miss Kentucky Teen America Organization's Pageants and the Continental Miss Teen America Scholarship Program, Inc., in case of any loss or injury occurring during, or in travel to and/or from this program.
11. Recipients of the title Miss Kentucky Teen America and Miss Kentucky Jr. Teen America titles promise to promote the program by making a minimum of 12 personal appearances during her reign. Titleholders further promise to make no personal appearances or appear in any advertising and/or publications without permission from the State Director. Titleholders in the Kentucky's Miss Princess Pageants agree to make a minimum of 6 personal appearances during their reign.
12. Miss Kentucky Teen America/ Miss Kentucky Jr. Teen America agrees to make no changes (ex: changing hair cut or color, piercings, etc...) to her personal appearance during the course of her reign without permission from the State Director.
13. Miss Kentucky Teen America/ Miss Kentucky Jr. Teen America/ Kentucky's Miss Princess Titleholders promise to return to the next annual pageant to crown her successor and assist with the operations of pageant weekend.
14. State and local representatives agree that they accept their titles with the understanding that they will compete at the next level and assume all responsibility for payment of fees not specified in the awards package.
15. Crowns and banners remain the property of The Miss Kentucky Teen America Organization until after the national competition. Any delegate who defaults on her contract must return all prizes and awards including her crown and banner to the state office in the condition in which it was received.
16. I further understand that there will be a \$25 fee assessed for any returned check. Failure to resolve a returned check with the state office will result in the check being turned over to the County Attorney in which additional fees will be assessed.
17. Applicants must be a resident of the state of Kentucky.
